Specification

The XPC001 Proctology Chair has been constructed from Aluminium for its strength and lightweight characteristics. The seat is manufactured from Natural Polyethylene

The chair is fixed height, but should accommodate all digital imaging machines. The armrest is fitted for patient comfort and safety, it has not been designed to be weight bearing.

This chair <u>must not</u> be used to transport patients. The chair must be positioned for the X-ray and then the patient is invited to use the chair.

A step has been fitted to allow easy patient access to the raised seat, this can be retracted once the patient is seated or when the chair is being manoeuvred.


The chair is fitted with two 125mm castors at the rear, when the chair is tilted backwards the chair can be manoeuvred easily (without the patient on the chair).

A protective collar with a lead band is provided with the chair, this when placed around the plastic bed pan (not provided) prevents scatter radiation, see Fig 1 on page 4.

<u>Maintenance</u>

It is strongly recommended that the following checks be carried out on a weekly basis by hospital personnel to ensure trouble free operation of the Chair.

- Check the vinyl pads for cracks or other obvious signs of damage or contamination. Report any damage found.
- Check rear castors for damage and free movement. Remove any debris as this can lead to a shortened life expectancy of the castor if left unattended.
- Check the step for ease of movement
- Check the Polyethylene seat for damage
- Check the Bed Pan locating blocks for damage

Cleaning

This product should be washed with a disposable cloth wrung out in a solution of warm water and detergent. The product should be rinsed with warm water and dried thoroughly with paper towels.

If required the product can be washed down with hand hot sodium hypochlorite solution up to 1% or 10000 parts per million chlorine combined with a detergent. Alternatively, follow your local guidelines or instructions.
